DURING SUMMER MONTHS, YOUTH SERVICES ADVOCATES PARTNER WITH LOCAL COMMUNITY EDUCATION AND YOUTH SUMMER PROGRAMS THROUGHOUT ANOKA COUNTY TO OFFER INTERACTIVE, EDUCATIONAL PRESENTATIONS ON HEALTHY RELATIONSHIPS AND BYSTANDER INTERVENTION TO MIDDLE SCHOOL AGE YOUTH. IN 2024, THE YOUTH SERVICES PROGRAM PROVIDED IN PERSON SCHOOL-BASED INDIVIDUAL ADVOCACY AND SUPPORT GROUPS TO 175 YOUTH; PILOTED NEW PREVENTION EDUCATION CURRICULUM TO ELEMENTARY-AGED CHILDREN, REACHING 223; REACHED 190 YOUTH VIA ON-SITE GROUPS/EDUCATION SESSIONS AT LINO LAKES JUVENILE CORRECTIONAL FACILITIES; AND REACHED 137 MIDDLE SCHOOL AGED YOUTH THROUGH SUMMER PROGRAMMING ACTIVITIES. IN ADDITION, 5120 STUDENTS FROM LOCAL MIDDLE SCHOOLS, HIGH SCHOOLS, AND COMMUNITY COLLEGES LEARNED ABOUT HEALTHY RELATIONSHIPS THROUGH THEIR PARTICIPATION IN ONE OF 274 CLASSROOM PRESENTATIONS AND 8 YOUTH COMPLETED OUR ANNUAL SUMMER LEADERSHIP INSTITUTE.

IN 2024, OVER 4,853 COMMUNITY MEMBERS AND PROFESSIONALS INCREASED THEIR AWARENESS AND KNOWLEDGE THROUGH PARTICIPATION IN ONE OF 84 COMMUNITY EDUCATION PRESENTATIONS, PROFESSIONAL TRAININGS, RESOURCE FAIRS, AND ORGANIZATIONAL EVENTS.
