



2025...A Year of Impact

Alexandra House stood beside survivors, answered calls for help, and built a safer community. Every number represents a life changed, a future reclaimed, and hope restored.

Providing Safety— 350 survivors and their children found refuge in our emergency shelter, spending a total of 8,346 nights in safety; with an average stay of 24 days. When space was limited, we ensured 31 families (63 people) found safety in hotels.

Answering the Call— 4,600+ crisis calls and online chats were answered, providing immediate support and life-saving resources.

Fighting for Justice— 530+ survivors received criminal and civil legal advocacy, including 128 seeking protection orders. Law enforcement referred 520+ victims through the Lethality Assessment Protocol, and 355+ high-risk survivors received immediate on-scene advocacy.

Responding to Crisis— 190 hospital and clinic referrals connected 188 victims of sexual and domestic violence to crisis intervention, safety planning, and support—ensuring no survivor faced their trauma alone.

Building a Community of Healing— 138 survivors and their children began their healing journey in support groups, with 200+ support group sessions offered. 44 participants were referred to our partner, Conscious Healing Counseling, and 25 received ongoing therapy.

Creating Stability— 56 families received ongoing advocacy, financial assistance, and housing support through Transitional Housing & Parent Support Outreach Program; 23 households benefited from long-term housing subsidies critical for rebuilding violence-free lives.

 **New in 2025 — Linus' Pet Haven:** 31 families (54 people) arrived with pets, staying an average of 25 days in shelter; 41 pets (18 dogs, 23 cats) were protected alongside their families, ensuring survivors could escape abuse without leaving a beloved companion behind.

Educating the Next Generation— 4,325+ youth participated in 410+ programs, activities, and presentations, learning about healthy relationships and violence prevention. Beyond the classroom, 110+ youth (victim/survivors) received personalized support through school-based advocacy and support groups, helping them navigate challenges and build safer futures.

Raising Awareness— 8,970+ community members gained critical knowledge through 110 presentations, professional trainings, and community events, creating a more informed and empowered community.

Protecting Older Adults— 36 older adults experiencing abuse, neglect, or financial exploitation received advocacy and support, ensuring their safety and dignity.

Mobilizing Volunteers— 483+ volunteers dedicated 10,972+ hours of service—equivalent to 7.5 full-time staff—providing hands-on support and strengthening our mission.

Through every call, every shelter stay, every act of advocacy, and every community connection, Alexandra House impacted the lives of more than 18,970+ people.

448 Lethality Assessments ensured 355+ high-risk survivors connected on-scene to an advocate.



Support Groups

138 survivors and their children found community and healing through 200+ support group sessions and 585+ services.



More Nights—More Lives Protected


Survivors found refuge in our emergency shelter, spending 8,345+ nights in safety. When beds were full, we found another way and housed 63 individuals in hotels.




